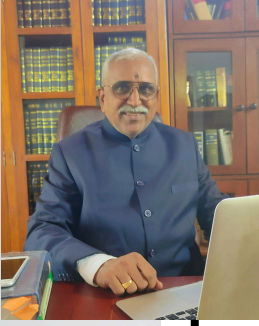

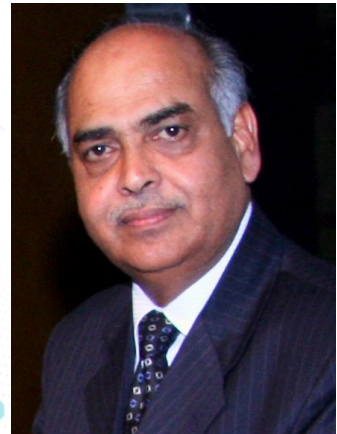

Who Are We?

CG3 had commenced its journey of connectivity by launching a National Webinar on the most debated constitutional topic of CONTEMPT OF COURT. It was inaugurated by Hon'ble Mr. Justice (Rtd.) Cyriac Joseph, Former Judge of the Supreme Court and presently Kerala Lok Ayukta. Hon'ble Justice (Rtd.) V. Chitambaresh, Former Judge, High Court of Kerala had also addressed the gathering as our guest speaker. After the successful completion of the first event, CG3 had conducted several national and international webinars. A national webinar on the topic HUMAN RIGHTS VIS-A-VIS GOVERNMENT was hosted by CG3 in august presence of Dr. Subramanian Swamy, Member of Parliament, Rajya Sabha. On that occasion, Dr. Swamy said that CG3 is the platform for the confluence of ideas not particular to any ideology and also conveyed that Government plays a major role in protecting the human rights as well as can also violate human rights when it fails in its duty to protect them. Further, it was continued by the next national webinar on the topic HUMAN RIGHTS VIS-A-VIS JUDICIARY. The Webinar was inaugurated by Hon'ble Justice (Rtd.) Kurian Joesph, Former Judge of Supreme Court of India. Dr. Manoj Kumar Sinha delivered the keynote address and Adv. Saji Narayanan gave a special address to the virtual gathering. CG3 had thereafter brought to the limelight in its next initiative CONFLUENCE OF IDEAS, where it laid foundation to the key phrase that ideology can differ; ideas need not necessarily. The webinar in Malayalam medium discussed it at length. Listen to the various tones set to same notes. This interesting virtual discussion was chaired by Hon'ble Justice (Rtd.) Cyriac Joseph, Former Judge of Supreme Court of India. The Panellist for the discussion included the current Law minister for the State of Kerala Adv. P. Rajeev, the current Leader of Opposition in Kerala Legislative Assembly Adv. V. D. Satheesan and Dr. K. S. Radhakrishnan, (Rtd.) Chairman of KPSC. Thereafter, it had

touched several fields like India's Fight Against Covid-19 Pandemic; Redefining Legal Profession & Legal Education Contextually With Pandemic; Development, Ideology & Nationalism In Democracy; Tackling Health Emergency – Kerala Paves The Path; and such many other webinars.

On the proud occasion of the 1st Anniversary Celebrations of CG3, the then Hon'ble Minister for Local Self Government Department, Government of Kerala, Sri M.V. Govindan Master, officially inaugurated the project of State-wide Workshop for Local-Self-Government Institutions. It was giving life to one of our visions of bringing legal aid and legal awareness made available to the last man in need. This project fulfils this motto by introducing legal awareness sessions to the elected members of Local Self Government Institutions, through whom we strive to reach out to all those people in need of instant legal aid. It was a matter of great honour for CG3 to have the esteemed cooperation, support, and guidance of all the authorities at the Panchayat level as well as at the Municipality level across Kerala for the successful progression of this project.

CG3 had also taken its earnest efforts in Legal Education and Awareness not only among the general public at large, but also had conducted classes and awareness programs for students and children. Legal Awareness and Monitoring Program which is in short called LAMP is the brainchild of CG3. In advancing towards the path of its noble cause CG3 has initiated a pious job of educating the children with the laws of our country. Children of class 8 to 12 comprise the focused audience of LAMP, who are sensitized about the laws to be known by them, its effects and implications. The programme is also intended to familiarize the student community with Law as a career. Apart from these we are organizing programs for Legal Research, Internship for law students and training of targeted groups.

Who Are We?

At the 1st anniversary function in July 2021, as stated above, CG3 launched its ambitious programme of organizing legal workshops for the elected members of the Local Self Government Institutions – Three-tier Panchayats, Municipalities and Municipal Corporations in Kerala covering about 21000 members. Simultaneously we launched LAMP – LEGAL AWARENESS AND MONITORING PROGRAMME for school students from standard VIII to XII reaching out to 67 schools in different parts of India. Further, with immense joy and confidence, CG3 with the aid, support and guidance of the Mediation and Conciliation Project Committee, Supreme Court of India and Kerala State Medication and Conciliation Centre, launched its new venture of Mediation Training Programme. CG3 in association with MCPC, Supreme Court of India and KSMCC conducted a 40 hours training programme for its members, who are practicing lawyers, and other registered law professionals. The training sessions were held in Kerala on physical mode in Thiruvananthapuram. The trainees include lawyers who are elected members of the local bodies and also lawyers belonging to tribal and Dalit communities. We have taken the initiative to set up a full fledged private mediation centre in the State of Kerala. We are also in the process of initiating projects for Development of Thiruvananthapuram as well as of the State and Nation as well.

What Do We Do?

Giving sustenance to one person is worth more than preaching to a thousand persons. Access to justice to the deprived and disconnected citizens by connecting them to the benefits of governance is the avowed motto of CG3. Facilitating the needy individually, collectively and improving the dealings with the State, its instrumentalities and agencies is the policy. This requires an organized team of enterprising entrepreneurs. The activities also include dissemination of information, updating of legal literacy positions, conducting seminars and workshops, publication of literature pertaining to human right activities and various connected programs.

CG3 has organized and executed 3 physical offline events namely the Mediation training 40 hours programme in association with the hon'ble Supreme Court Mediation and Conciliation Project Committee, 3-day Legal Workshop for the Drug, enforcement officers Kerala in association with the State Government of Kerala and one-day Legal workshop for the Drug Manufacturers in association with the State Government of Kerala.

CG3 has also organized many virtual events till date, which includes 8 webinars and 4 memorial services. Eminent orators, renowned academicians, scholarly jurists and political experts are invited to deliberate on various themes of social relevance involving contemporary legal issues, reaching out its essence to the esteemed guests, invitees, participants and audience.

Moreover, CG3 has accomplished its flagship project of organizing legal workshops (LSG Workshops - Local Self Governance Workshops), for the entire people's representatives covering the province of local self-government in the Panchayats of all the 14 districts of Kerala. The formal inauguration and launching of the said workshop, by Shri. M. V. Govindan Master, Hon'ble Minister of LSG & Excise, during the first anniversary of CG3 marked the beginning of the mission to make legal aid and services accessible to all sections of the society through the people's representatives.

In addition, we have successfully ignited our LAMP- Legal Awareness & Monitoring Programme in 65 schools across India and also 1 in Nepal. We are happy to have made a global impact. As a custodian of law this drive comes with a duty to educate our children about the laws of our country and ensure that they understand them and also abide by them.

CG3 organised a **Special CG3 Convention 2023** on 26.10.2023. The major announcements on the road ahead for CG3 were made during this session.

CG3 inaugurated its Thiruvananthapuram Office on this day. The inauguration was headed by Honourable Dr. Mr. Justice K. G. Balakrishnan (Retd.), Former Chief Justice of India & Chairperson Human Rights Commission, India; Dr. Prof. N.K. Jayakumar, Chairperson Law Reforms Commission, Former Advisor (Law) to the Chief Minister of Kerala & Former Vice Chancellor, NUALS; Honourable Mr. Justice Cyriac Joseph (Retd.), Former Judge, Supreme Court of India and Human Rights Commission, Kerala; Sri. Prabath Kumar, District Judge and was attended by more than 50 members both offline and online.

CG3 is on the road to **“Mission Mediation”** and to further this concept we have taken an initiative to setup a Mediation Centre. With a strength of 26 mediators of which 24 mediators were trained with CG3 under the aegis of Mediation and Conciliation Project Committee of Supreme Court of India we have a full fledged mediation centre and each mediator is equipped to handle various mediation matters irrespective of whether it is family matter, corporate matter, societal issue and so on.
